



Accreditations Procedures

To foothold in the Mahatma Gandhi Technological Park, the eligible companies (ICT and BIOTECH) must perform the following procedures:

- 1. Creation of a legal entity (ex. Subsidiary) in Côte d'Ivoire
- 2. Submit an application for approval to VITIB (Accreditation Application Form available for download at www.vitib.ci)

The application process is done quickly and the decision of the Accreditation Committee is obtained within a month.

Investment and development program

Launched in 2014 with support from the State of Côte d'Ivoire and its international financial partners, the program is managed by a Project Implementation Unit (PIU). Current projects are:

VITIB S.A.

Law No. 2004-429 of August 2004 establishes the regime of the Free Zone of Biotechnology and Information Technology and Communication (ZBTIC) in Ivory Coast. It covers an area of 700 ha, in the North edge of the historic seaside town of Grand-Bassam.

November 30, 2006, the Company VITIB S.A., limited company with capital of 3 billion FCFA and minority public financial contribution was born. This Free Zone Authority is granted with full public service delegation, in accordance with the law establishing the system of ZBTIC. VITIB consists of national and international partners alongside the State of Côte d'Ivoire.

Our Vision

Under a concession agreement with the State of Ivory Coast carrying delegation of public service, VITIB SA aims to make the free zone the leading technology park in Africa for the development of ICT and biotechnology sectors in Africa, with the benefits of FREE ZONE status.

Hosting Companies

Data Center

Data Center (white room) up to international standards, adjusted according to specific needs, open to licensed companies and other entities wishing to securely host their data. Storage spaces are available, from single U to multiple racks. Data Centre is powered by three separate energy sources, with redundant access to the largest Telecom operators established in Côte d'Ivoire (FO connection to WACS, ACE and SAT3).

Incubation and Training

One of VITIB SA mission is to develop within the free zone a dynamic ecosystem for innovation, the emergence of talented entrepreneurs and SMEs / SMIs which creative wealth and value. For this, VITIB has setup a business accelerator with high potential, provided with advanced equipment and in which entrepreneurs receive adequate training and coaching, so as to mature their business ideas.

Resort

The free zone includes a modern hotel complex serving both the needs of businesses in operation as those of various clients who decide to hold their group training sessions surrounded by the generous nature of the site.
